PROCESS FOR PUBLIC PARTICIPATION: DRAFT AIR QUALITY BY-LAW FOR THE CAPE WINELANDS DISTRICT MUNICIPALITY

Notice is hereby given in terms of section 17 of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), read with section 156(2) of the Constitution of the Republic of South Africa, 1996, and section 11(1) of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004), that the Council, at its meeting held on 18 August 2025, under Item C.15.10, approved the Cape Winelands District Municipality Draft Air Quality Management By-law for public participation.

The purpose of the By-law is to enable the Municipality to exercise its legislative authority to manage air quality and control air pollution within the jurisdiction of the Cape Winelands District Municipality, ensuring that air pollution is either prevented or, where it cannot be entirely avoided, is minimised and appropriately remedied.

Public representations, inputs and comments on the Draft Air Quality Management By-law must reach the Office of the Municipal Manager before 12:00 on Wednesday, 15 October 2025.
